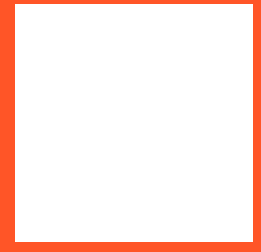

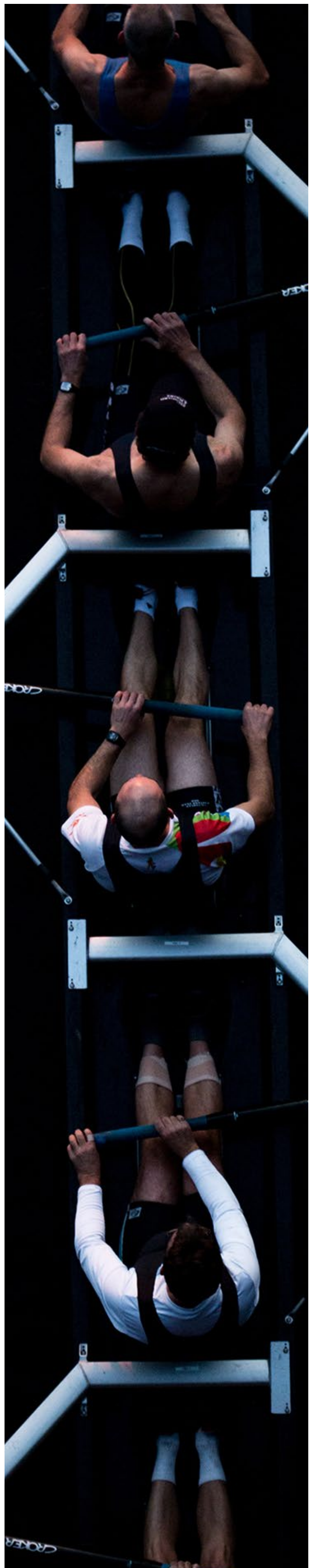



About us

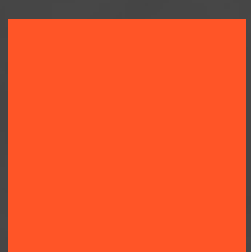
